# History

March 1952	Ogawa Eiseisha was established. Its main business was collection of human waste and garbage.
April 1965	Ogawa Industrial Co., Ltd., established and registered as a corporation. Maintenance and management business of septic tanks started.
March 1981	Motoyama Factory ( Recycle Center) completed and started operations.
July 1990	Operation of incineration facilities for waste was started.
June 1997	The name of Ogawa Industrial Co., Ltd. was changed to OGAWA ECONOS, Inc.
January 2003	Ukai Factory was expanded and operation of the residual food composting plant was started.
November 2004	Tokyo Office was opened.
February 2005	The new Okayama Factory was built and operation of the RPF manufacturing plant was started.
November 2006	The new Sendai Factory was established and operation of RPF manufacturing plant was started.
March 2018	The new Fukuyama Factory was established and operation of compression facilities for waste plastic and used paper was started.
